Comment

Following the acceptance of the Annual Report, Council is required to give public notice of the availability of the Annual Report as soon as practicable. It must also be posted on our website within 14 days of being adopted.

It is also a requirement that a General Meeting of Electors is to be held on a day set by Council not more than 56 days after acceptance of the Annual Report, with 14 days local public notice of the meeting being given. The last day that the Annual Electors Meeting could be held is Wednesday 16 February 2022.

The Annual Report must also be published on Council's website within 14 days of being adopted by Council.

The 2020-2021 Annual Report will be distributed to Councillors at the meeting.
