## Terms and Conditions

The recipients of this agreement do hereby apply for membership entry to the Bruce Rock Gymnasium, owned and operated by the Shire of Bruce Rock, located Johnson Street, Bruce Rock, Western Australia. In consideration of the Shire accepting the membership entry, I agree to be bound by the following terms and conditions:

1. All users must have obtained a swipe card (to enter) from the Shire Office during office hours. This card will be programmed into the system for your **personal use only**. Distribution of the card to family members, friends or other people will result in the cancellation of your card and gym membership. If your card is lost or stolen please notify the Shire and the card will be cancelled.
2. The Bruce Rock Gymnasium building and equipment are for members only. Allowing non-members access into the facility will not be tolerated and may result in cancellation of your membership.
3. The Shire urges that before use, people are aware of how the equipment works. The best method of this is to consult the local Physiotherapist. Please bring a towel to the gym if you are using any of the machines and wipe them clean after use.
4. The Shire strongly urges that users seek advice from either your Doctor or our local Physiotherapist to set programs.
5. Please ensure the utmost care will be taken within the gym and the equipment provided. Please report any defective or damaged equipment to the Shire as soon as possible.
6. Please ensure that the Gym is kept clean at all times.
7. The Shire has supplied this gym and hopes the community will support the venture. The venue will not be supervised and it is hoped users will look after the venue. After you enter, the door mechanism will automatically lock. To leave the venue press the button on the right of the door before you leave. On exiting the gym please ensure the door is locked. **Remember, you enter at your own risk.**
8. There can be no entry to the Pool from the Gym unless there is a fire emergency. If you are to have a swim after using the Gym, you must use the main entry door, and enter the Pool through the entrance. Please ensure the door to the toilets is locked when leaving. Usage of the fire emergency door in any other circumstance than a fire emergency will be seen as **trespassing and you may be prosecuted.**
9. It is advised that you have the correct attire while exercising eg. comfortable clothing, good sports footwear, towel and water bottle. No bare feet or thongs allowed.
10. **No person 12 years or under** shall be permitted into the Bruce Rock Gymnasium. Children 13 to 16 years old, who are members, must be supervised by an adult 18 years or over at all times. All persons supervising anyone under 16 years of age must be a member of the gym.
11. **This agreement is subject to a 48 hour cooling off period.** Should a member wish to cancel the membership within the 48 hour cooling off period, the member is required to contact the Shire of Bruce Rock's Administration and request cancellation of the membership. A full refund will be given, once the swipe key has been handed over.
12. Members may terminate the agreement by ringing or writing to the Shire of Bruce Rock Administration Office. Should the membership agreement be terminated by the Shire of Bruce, the member will receive written notification.
13. The Shire is under no obligation to refund the membership fees if the member changes their mind after the cooling off period. In the event of exceptional circumstances consideration may be given for a refund (pro-rata) on written request.
